# Federal Home Loan Bank of Indianapolis (FHLBank Indianapolis) Disaster Relief Program

### **Program Overview**

The Disaster Relief Program (DRP) is designed to provide rapid, short-term financial assistance to households impacted by federally or state-declared disasters or emergencies within the FHLBank Indianapolis district. Funds will be disbursed through FHLBank Indianapolis member financial institutions that serve the affected communities. The program enables members to deliver flexible financial support to help households with immediate relief from natural disasters such as floods, tornadoes, wildfires or other catastrophes.

## **Program Objectives**

- Provide emergency assistance to households affected by declared disasters.
- Support member institutions in responding quickly to community needs.
- Bridge the gap between disaster occurrence and longer-term recovery resources.
- Reinforce community stability by reducing financial disruption for vulnerable households.

## **Eligible Recipients**

- Owner-occupied households in single-family homes located in a federally or statedeclared emergency or disaster area.
- Households must have been directly impacted by the disaster.
- Households with incomes <100% of the Median Family Income in the county in which the property is located. See <u>Huduser.gov</u> to determine income limits.

## **Eligible Uses of Funds**

- Temporary housing or lodging expenses
- Emergency home repairs (e.g., roofing, windows, structural safety)



- Emergency power supply
- Replacement of essential household systems (e.g., heating/cooling systems, sump pump, water heater)
- Utility reconnection fees
- Transportation for relocation or medical needs
- Uses not listed here must be approved by FHLBank Indianapolis prior to disbursing funds on behalf of households.

#### **Funding Parameters**

Grants of up to \$10,000 per household. Maximum allocation per member institution is \$25,000. Funds must be disbursed to qualified households within 30 days of member receiving the funds, unless otherwise extended.

#### **Member Institution Eligibility & Responsibilities**

- Must be an FHLBank Indianapolis member in good standing.
- Must complete a DRP Master Agreement.
- Must complete a DRP Program Application.
- Responsible for verifying household eligibility.
- Responsible for collecting documentation of need.
- Responsible for disbursing funds directly to impacted households.
- Must disburse funds to households within 30 days of receiving program funds.
- Responsible for returning any unused funds back to FHLBank Indianapolis.
- Submitting a final impact report within 90 days of receiving program funds.
